NOTICE IS HEREBY GIVEN that the City of Grover Beach encourages residents to apply to serve on City Commissions and Committees. When vacancies occur, the City recruits for applicants by publishing Notices of Vacancies in the local newspapers, posting the notice in the City's three (3) public posting locations, as well as the City website, Facebook, and Government Cable Access Channel 20.

NOTICE IS FURTHER GIVEN that the City is seeking citizens interested in serving on the following advisory bodies:

- ❖ **PARKS, RECREATION & BEAUTIFICATION COMMISSION:** **Two (2) seats** are open with the expiration of two Commission terms as of March 31, 2017. Terms on the Commission are four-year periods, with no term limits. Individuals serving on the Commission must also apply to be considered for re-appointment. The Parks, Recreation & Beautification Commission is a body of five (5) citizens that meet on a monthly basis, usually on the third Thursday of each month at 6:30 p.m. The Commission serves as an advisory body to the City Council and the Parks and Recreation Department, providing recommendations on issues involving parks, recreation, City-sponsored special events, and beautification efforts. - ❖ **PLANNING COMMISSION:** **Two (2) seats** are open with the expiration of a two Commission terms as of May 31, 2016 and May 31, 2017. Terms on the Commission are four-year periods, with no term limits. Individuals serving on the Commission must also apply to be considered for re-appointment. The Planning Commission is a body of five (5) citizens that meet on a monthly basis, usually the second Wednesday of each month at 6:30 p.m. The Planning Commission is a planning agency authorized by law to grant or deny land use approvals. The Planning Commission also reviews and makes recommendations on the community's General Plan. Major areas of involvement are real estate development projects and business uses. Interviews with interested applicants are typically held before a City Screening Committee, with recommendations forwarded to the City Council for consideration and appointment(s) at a regular City Council meeting. Applicants must be registered voters of the City of Grover Beach.
