**NOTICE IS HEREBY GIVEN** that the City of Grover Beach encourages residents to apply to serve on City Commissions and Committees. When vacancies occur, the City actively recruits for applicants by publishing Notices of Vacancies in the local newspapers, posting the notice in the City's three (3) public posting locations, as well as the City website and Government Cable Access Channel 20.

**NOTICE IS FURTHER GIVEN** that:

- **The City of Grover Beach is currently seeking interested citizens for appointment to the Parks, Recreation and Beautification Commission.**  
**One (1) seat** on the **Parks, Recreation and Beautification Commission** is scheduled to expire on May 31, 2011. Terms on the Commission are four-year periods, with no term limits. Individuals serving on the Commission must apply to be considered for re-appointment.

Interviews with interested applicants are typically held before a City Screening Committee, with recommendations forwarded to the City Council for consideration and appointment(s) at a regular City Council meeting. Applicants must be registered voters of the City of Grover Beach.

The Parks, Recreation and Beautification Commission is a body of five citizens that meet on a monthly basis. Meetings are usually held on the 3<sup>rd</sup> Thursday of each month at 6:30 p.m. The Parks, Recreation and Beautification Commission serves as an advisory body to the City Council and the Parks and Recreation Department regarding parks, recreation, community events, and beautification efforts. The Commission is actively involved with the Parks and Recreation Department, advising the Department on special events throughout the year.
