**Vacancies that Occurred During 2016:** Notices of Vacancy were: 1) posted at City Hall, Grover Beach Post Office, and Grover Beach Train Station; 2) distributed to the local media; 3) posted on the City website; and 4) posted on Government Cable Access Channel 20. The appointment process typically includes an interview before a Screening Committee, followed by approval and official appointment by the City Council at a noticed public meeting.
